

Prevent for Safeguarding Officers two day course

The first session is at Kirklees College: Huddersfield on 10th and 11th December. Sessions will follow in Birmingham and London. These and other sessions will be timetabled according to demand

Who is this for?

Safeguarding officers or members of the Safeguarding team

Why should I attend?

This is an intensive two day course which will give you the latest information on Prevent duty requirements. You will have the opportunity to:

- Review examples of policies and procedures and consider how to adapt these to your organisation
- Discuss the Duty and the Channel process with Prevent professionals
- Review case studies and discuss actions with Prevent and Safeguarding professionals
- Explore examples of how to implement British values and discuss how to implement British values in your organisation
- Explore ways to support staff in challenging extremism.

This two day intensive course will cover the elements of the Prevent duty and give Safeguarding officers a chance to discuss implementation with Prevent professionals and fellow Safeguarding Officers.
